Public Inspection Requirement

THEY ALSO ADMINISTERED 48,851 VACCINATIONS, WHICH INCLUDED LOW-COST SHOT CLINICS. 7,052 MICROCHIPS WERE IMPLANTED SO THAT OWNERS WOULD BE ABLE TO RETRIEVE LOST PETS. THEY WERE ALSO ABLE TO PROVIDE VETERINARY SERVICES TO ANIMALS WHOSE OWNERS WOULD NOT OTHERWISE BE ABLE TO AFFORD SIMILAR TREATMENT AT FOR-PROFIT ANIMAL CLINICS.
